1. Executive Summary

The European Data Forum 2014 (EDF2014) took place from March 19-20, 2014 in Athens, Greece at the Royal Olympic Hotel. EDF is the annual meeting-point for data practitioners from industry, research, the public-sector and community initiatives, to discuss the opportunities and challenges of the emerging Data Economy in Europe and took place in the third edition in 2014.

The total number of registrations was 620 (coming from 45 different countries and 363 different organizations) whereby 455 people attended the conference (coming from 36 different countries and 233 different organizations) what is equivalent to a no-show rate of 26.6%.

EDF2014 started with a welcome and opening session by Neelie Kroes, Vice President of the European Commission, in charge of the Digital Agenda, Kyriakos Mitsotakis, Minister of Administrative Reform and e-Governance of Greece; Evy Christofilopoulou, Deputy Minister of Administrative Reform and e-Governance of Greece and Christos Vasilakos, General Secretary for Research and Technology of Greece.

Johann Mittheisz, former CIO of the City of Vienna, Austria, and the Open Government team of Vienna was awarded the Eccenca European Data Innovator (EDI) Award for 2014, in recognition for exemplary actions and innovations in the Data Economy, for the outstanding work on Open Data and Open Government in the City of Vienna, in Austria and the whole D-A-CH region.

The EDF2014 was chaired by Manolis Koubarakis (Kapodistrian University of Athens, Greece) and Martin Kaltenböck (Semantic Web Company, Austria). The programme included 3 keynote talks, 3 panel sessions and a total of 39 talks from which 19 presentations were selected from the Call for Contribution that had 112 submissions. Furthermore a poster session with 25 posters as well as a 2 days exhibition with 30 exhibitors took place. EDF2014 offered additionally five collocated events on the days before and after the Forum.

2. Overview of EDF2014

1.1 EDF in a nutshell

The European Data Forum (EDF) 2014 took place from March 19-20, 2014 in Athens, Greece at the Royal Olympic Hotel. EDF is the annual meeting-point for data practitioners from industry, research, the public-sector and community initiatives, to discuss the opportunities and challenges of the emerging Data Economy in Europe.

EDF 2014 included keynotes from global experts in the field, invited and selected (from Call for Contribution) presentations, panel sessions and a 2-day exhibition. Focusing on recent developments (Open Data, Linked Data and Big Data), EDF 2014 balanced between technical, application and socio-economic issues. The talks delivered at EDF 2014 also provided input to research, project development, as well as policy activities at the European Commission (e.g. Horizon 2020) and to other relevant activities at EU member states. Central aim of EDF 2014 was to bring together all stakeholders involved in the data value chain (and above). It also encouraged the exchange of knowledge and ideas leading to the strengthening of the European data economy and its positioning worldwide.

1.2 Mission and objectives

The European Data Forum (EDF) is an annual meeting place for industry, research, policy makers, and community initiatives to discuss the challenges and opportunities of data in Europe, especially in the light of recent developments such as Open Data, Linked Data and Big Data. The forum balances technical (the technology and infrastructure needed to master the volume, heterogeneity and dynamicity of today's data), application (new products and services that are now possible due to Open Data, Linked Data and Big Data), and socio-economic issues (social impact, legal issues, government policies and regulations, business models, commercialization and innovation in this new era).

Our aim is to bring together all stakeholders involved in the data value chain to exchange ideas that address the above challenges and opportunities, in order to strengthen the European data economy and its positioning worldwide. Discussions at EDF provide input to research, development, and policy activities at the European Commission (e.g., Horizon 2020) and those of the EU member states, with the aim of influencing the development of the new European data economy.

An additional goal of the European Data Forum is to establish and foster a truly European data community and ecosystem. This emerging community enables promising ideas to move from the stage of research questions all the way to successful deployment and market introduction. At the same time, its stakeholders will mutually reinforce their strategies that will result in a forward-looking, dynamic, and well-integrated EU-wide ecosystem.

Because of the strategic importance of multilingualism in Europe, EDF promotes the integration and co-operation of the European data community and the language resources and technology community. The synergy of these communities is critical for new types of multilingual digital services and the creation of a European digital single market without language barriers.

1.3 Registration/Attendee analysis

The **total number of registrations** for EDF 2014 was **620** (631 registrations via website, 85 of these registrations non-valid, 74 additional registrations mainly via email). Additionally 50 (unregistered) visitors came by the registration desk for paper form registration. So in total **455 people attended the conference**.

The conference offered a number of travel grants for European SMEs and other organizations from a total of 9 applications for such funding 7 travel grants were managed. The guidelines and eligibility criteria can be found at <http://2013.data-forum.eu/conference-venue/edf2013-travel-grant>.

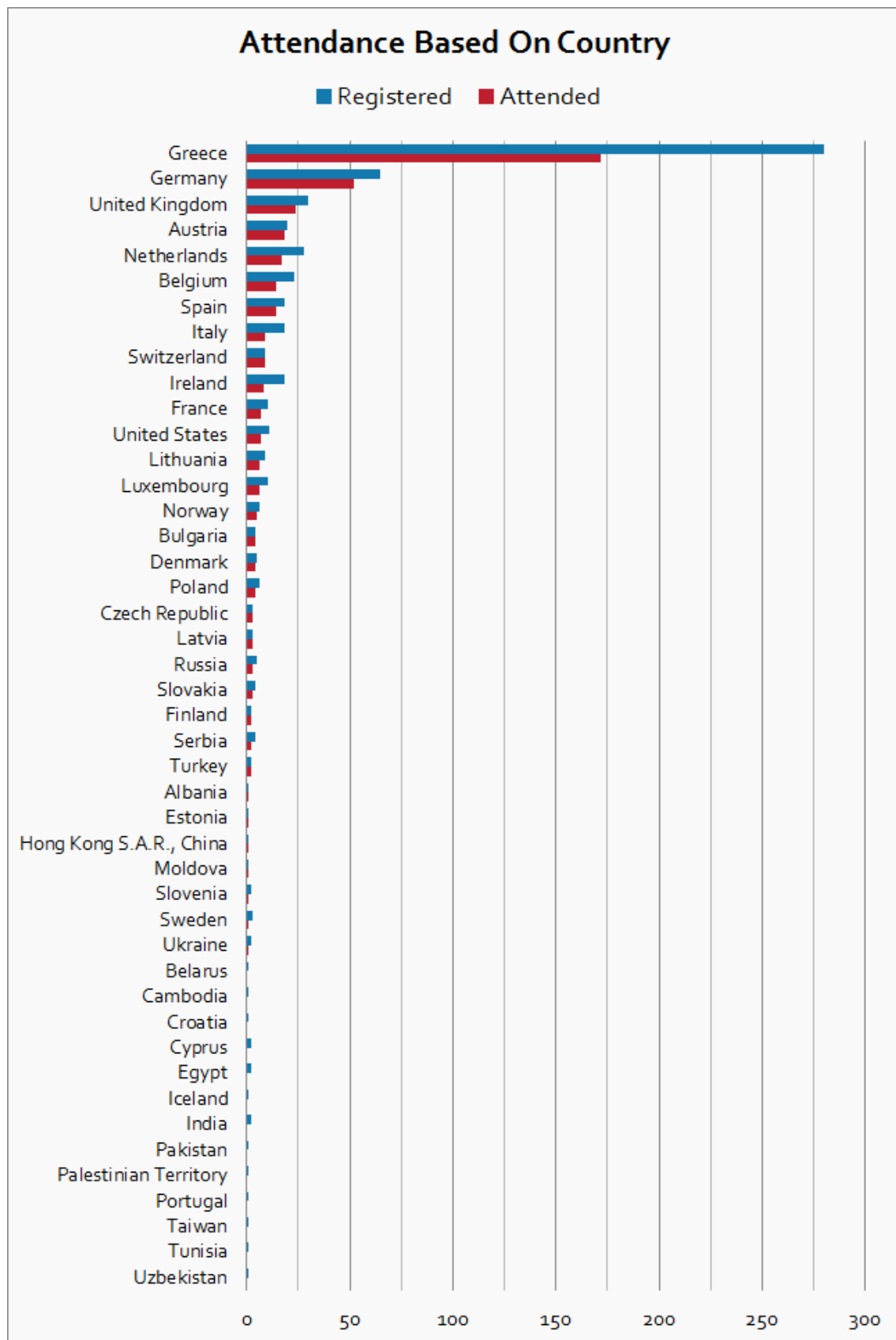


Fig.: EDF2014 Attendees by Country

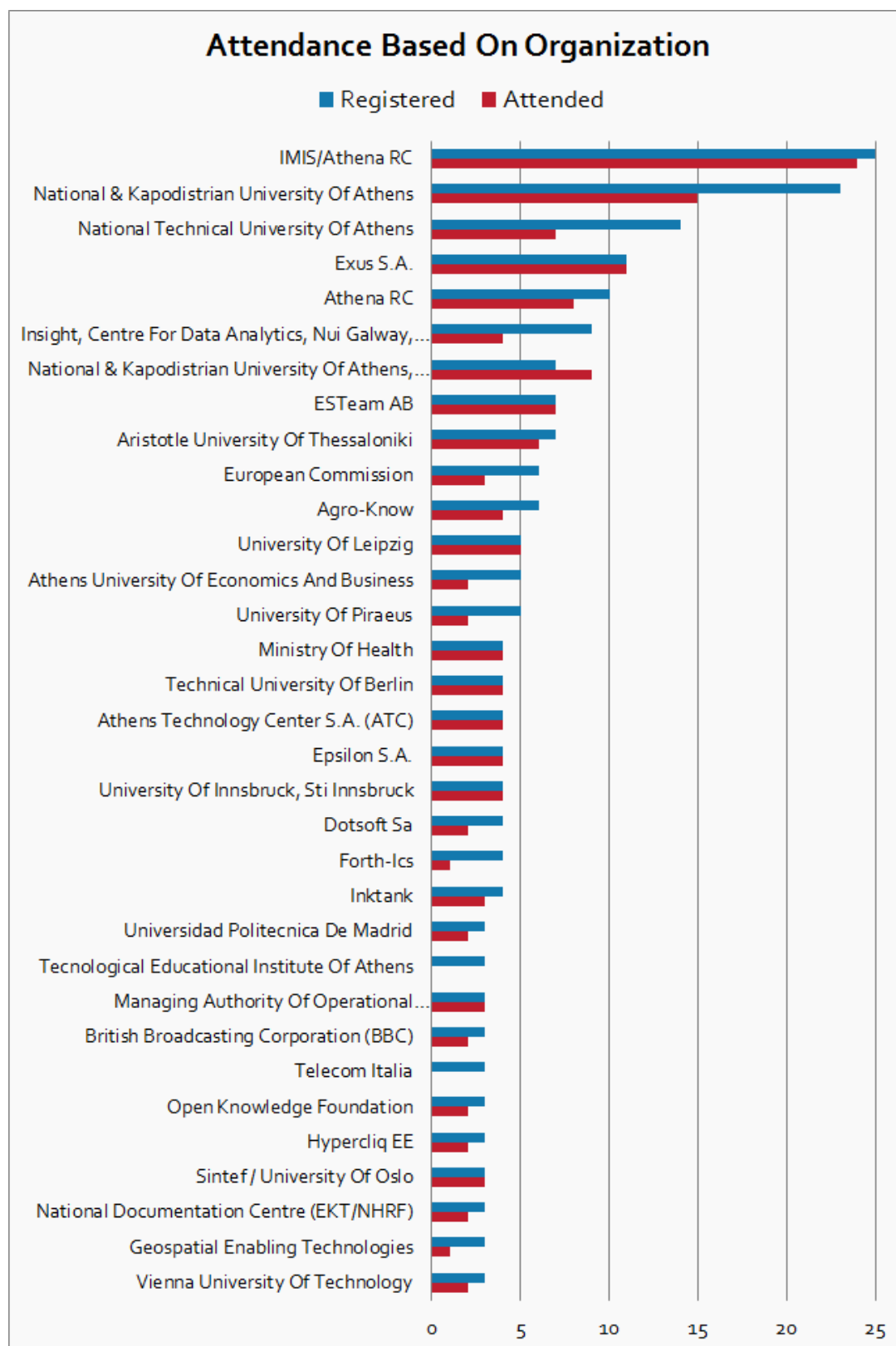

Acquiring a critical mass of (industrial) sponsorship proved to be one of the most challenging aspects of conference organization in 2014. While interest from the industry increased compared to the first and second edition of the conference, there is significant room for improvement in particular with respect to the representation of major industrial players in the data value chain (regional, national and international). A viable option seemed to associate sponsorship with keynote and invited talks; independently of this option, it is recommended that sponsorship efforts are initiated as early as possible, as this also has a positive effect on the planning of the technical program of the conference, thus making the overall event more attractive for further participants and potential sponsors. Securing the support of several important Data and Big Data players early in the process is expected to be essential for the further growth of the EDF.

3. Conference programme and collocated events, including speakers, Innovation Award, accepted submissions, Call for contribution, submission numbers and acceptance rates

2.1 The Main Conference

The programme of EDF2014 consisted of a mixture of keynote talks, invited talks and accepted / selected talks which have been submitted by various stakeholders in the European data value chain in response to a Call for Contributions issued by the EDF2014 organization committee led by the 2 programme chairs Nicoletta Calzolari (Institute of Computational Linguistics, National Research Council, Italy) and Jens Lehmann (University of Leipzig, Germany). The choice of talks was motivated by several criteria. First and foremost, the organization committee had a vested interest to put together a program that is representative and relevant for a wide range of organizations involved in the European data ecosystem. This influenced the selection of topics (technology, case studies, policy-oriented, research) and speakers (private organizations of different sizes, operating in various industrial sectors, public administration, including data providers and policy makers, and research centers). Second and fully aligned with the mission of the EDF, the organization committee understood the Athens event as a critical instrument to support and strengthen a thriving data economy in Europe. As such we were interested in promoting institutions based or having a strong European presence. In the following we will elaborate on the three components of the main program.

2.4 Eccenca European Data Innovator (EDI) Award

Johann Mittheisz, former CIO of the City of Vienna, Austria, and the Open Government team of Vienna was awarded the Eccenca European Data Innovator (EDI) Award for 2014, in recognition for exemplary actions and innovations in the Data Economy, for the outstanding work on Open Data and Open Government in the City of Vienna, in Austria and the whole D-A-CH region. The award was handed over by Commissioner Neelie Kroes, the Deputy Director General of DG CONNECT Robert Viola, and H.C. Brockman CEO of Eccenca.

Neelie Kroes congratulated him: “You are not preaching but practicing. Go on and inspire all of us” and pointed out that Vienna can be a role model for other cities in Europe. Mr. Mittheisz received the award and highlighted the significance of Local Administrations in promoting the Open Data agenda: “I’m working 41 years for the city of Vienna. It’s great pleasure to receive this prize”.

2.6 Invited and Selected Talks

The remaining program of the main conference was structured as a mixture of talks oriented towards research challenges, technology, standards and policies, as well as use case requirements and case study presentations. From a total of 37 talks, 19 talks have been selected in response to an open call for contributions (See list of selected talks including slides: <http://2014.data-forum.eu/program/selected-speakers>) and the remaining 18 presentations / talks were opening talks, keynotes and invited talks suggested by the organization committee. This methodology ensured a balance between topics covering the mission of EDF, different types of stakeholders, and interest of the broader community. The call for contributions attracted a great deal of attention; we received 112 submissions, of which 19 were selected by the organization committee for presentation in Athens. This workshop is organized by the European Commission and the German Ministry of Economics and Energy with the kind support of the Greek government.

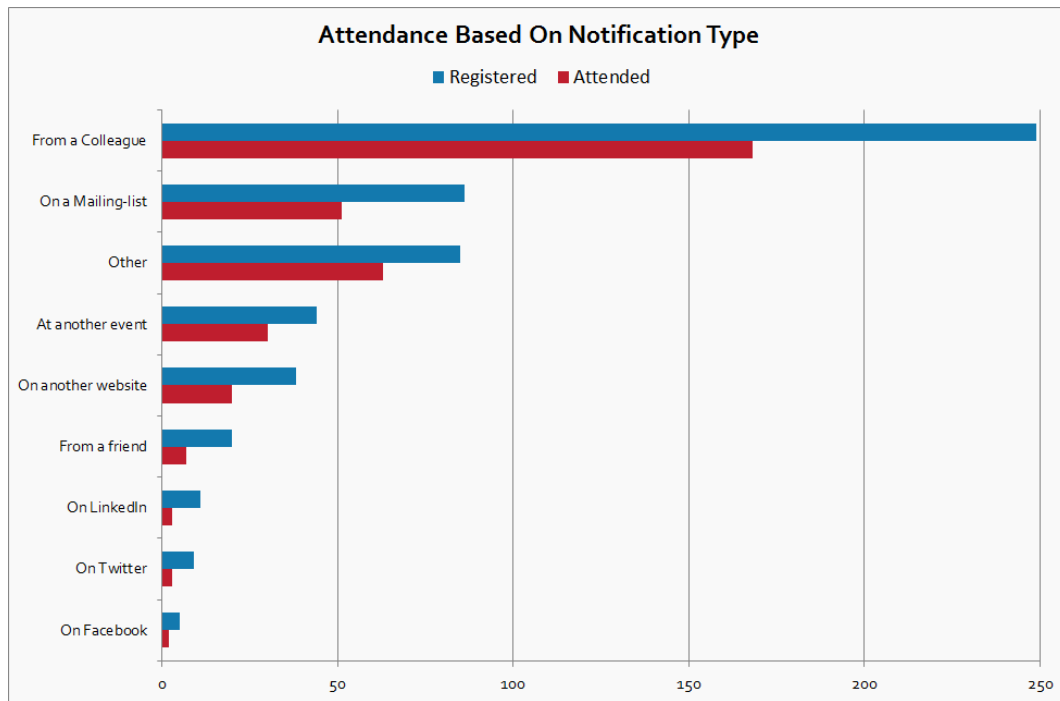
